- Our History

The Twin District Volunteer Fire Company began in the early 1940's when several men in the area reacted to the unsatisfactory performance of the South End Fire Company on Aurora Street. The South End Company had not been answering calls, and neighbors of the William and Aurora Streets community took steps to form their own company. Among the first members were Arthur Peters, Lester Moore, Albert Snyder, John Olsen, Joseph Hoerner, Norman Pfeil, Jerome Radamacher, Emery Cardinal, Walter Samulski, and Norman Petri. These are the names of the original incorporation papers.

At their first official meeting, at the District Seven Schoolhouse on October 21, 1942, the members were warned that the Lancaster South End Fire Company would take action against the company for interfering. "If they wish to continue they will encounter trouble," was the warning sent to the founders. Despite this threat the members voted to carry out their plans.

The Lancaster Town Board did not get involved in the dispute, as it had no grounds for dissolving South End, or preventing the formation of Twin District. Nor was a merge feasible, as neither party desired that solution.

The men continued to meet and discuss the future of their new fire hall. The meetings were held in Norm Petri's service station, on the corner of William and Aurora streets. The members voted for incorporation in 1942, and made arrangements with the Town of Lancaster to begin a fire company that would protect the area between Bowen road on the east, Transit road on the west, Hall road on the south and Como Park boulevard on the north. In that same year the first officers were elected, an account was opened at the Citizen's National Bank of Lancaster, and the members retained legal advisement. Listed in the minutes of the first meeting are the original officers: A. Radamacher, President; E. Cardinal, Vice President; W. Samulski and A. Gajewski, Secretaries; N. Petri, Treasurer.

The next main concern of the firemen was to secure land and build a firehouse. Three sites were considered, all of them located on William Street. Mr. Norm Petri, a Twin District fireman, offered to lease a portion of his land, Mr. John Jerge, also a fireman, proposed to donate one acre to the fire company, and Mr. Bippert offered the largest piece of land, but the terms of obtaining said land were unknown. Southeast Lancaster was farmland, and most residents struggled to maintain a minimum standard of living. For obvious economical reasons, Mr. Jerge's generous donation was accepted.

The original structure was a small wood building which was moved to the present site from the premises of Mr. Arthur Peters. Mr. Joe Lorentz transported the structure with his steamer. (Both men were original firemen.) The telephone and electric wires had to be lifted to accommodate the barn, (the police didn't appreciate that!) The building had one stall and no heat. In fact, the water in the tank of the 1936 Chevrolet pumper froze one winter.

The firemen began raising funds for a new building. They collected loans and donations, and held picnics, card parties and dances. By July 7, 1943, the foundation was dug for the new building. Money was also raised for other necessities, such as a siren, and a truck. The picnics raised the largest amounts of money for the firehall, and an equally proportional amount of time went into planning them. The minutes of a meeting from 1944 contains this passage: "A lengthy discussion on the price of hot dogs, it was finally placed at fifteen cents for good wieners, charcoal broiled." Twin District also gained a reputation for "one of the best clam chowders in the country." Twin District chowder was an integral part of every picnic, and the minute books from the 40's and 50's are

brimming with references to this potent amalgamation. Many firemen were honored with being the caretakers of this soup including John Schwartz, Floyd Wendel, A. Kidder, Joe Hoerner, and J. Costello. The first picnic was held at Broadway Park, on Broadway in Depew, but from 1947 on they were held on the grounds around the hall. Firemen gave not only their time, but some years had to throw five dollars into the picnic pot. Unfortunately the picnics ended in the early 1960's due to a lack of interest and manpower.

As early as 1943, the men of Twin District had the operation running smoothly. They built a hall, acquired a truck, and were responding to calls. The first truck was a 1936 Chevrolet which was assembled piece-meal by the members. The engine and chassis were purchased for \$150 and the body for \$25. Several firemen built the wooden tank, and years later it was lined with sheet metal. The truck was also an open cab, and unfortunately, back in 1948, Ed Dunnigan nearly lost his scalp on the cab when the brakes failed, and the truck crashed en route to an Elma fire. The firemen also dug a CONSTITUTION and

ies kept everyone busy every weekend of the summer. Firemen would travel to another company, march in their parade, and have a social gathering back at the host's hall. These events brought in money and support for the fire hall, and all members were requested to march. In the 40's and 50's field days were held frequently, and the presidents and chiefs of the company were adamant about attendance. When in 1950, Joe Hoerner was interrogated about missing a parade he replied, "it rained pitchforks and hoe handles!" The firemen of Twin District, as volunteers, donated their time to fight fires and protect the community. They gave even more time to the creation and maintenance of the company, and what little time and money they had left, was given freely. They sponsored a bowling team at St. Mary's, planted four hundred Norwegian Maple seedlings around Lancaster, sponsored a Drum Corps in the late 1950's (the instruments cost approximately \$1000), constructed a baseball diamond, and assisted the Boy Scouts.

Boy Scout troop 545 had their first meeting May 12, 1948, with George Schultz as the Scoutmaster. The company's first benevolent gesture was the donation of a flag, and in 1952, Roy Meutel and George Schultz built the scout's log cabin that still stands on the southwest corner of the property.

On June 3, 1946 the firemen extended a hand once again. Lester Moore invited the women to use the fire hall, and gave them \$100 to start the Ladies Auxiliary. The ladies and the firemen had a symbiotic relationship, donating money back and forth whenever the other has needed it.

Firemen possess the intrinsic quality of altruism, and besides helping the community around them, they also cared for each other. In the old days, if a member was in need, the men chipped in and gave a donation. In 1955 it was voted unanimously to award surviving families of deceased firemen monetary benefits. At that time it was \$160. In 1950, the "Sunshine Club was formed to take care of sick members, presenting cigarettes, [medical science has obviously advanced], fruit baskets or flowers." The company has always been a team, working together, whether the adversary was fire, sickness, or the waterball and tug-of-war competitions at field days.

The firemen of Twin District did their best to develop a ready, responsive, dependable company to take the place of the fading South End Fire Company. Both companies were tested regularly, for attendance at drills. By 1950 South End could no longer keep acceptable response times, as they had only five remaining members. Twin District offered a merge at this time

but the other company was unwilling. The Lancaster Town Board was unable to disband the South End company, but they did stop giving them money. Ultimately in September of 1950 the Town Board signed an exclusive contract with Twin District, which gave them \$700 for that year. Within two years the company had negotiated a contract with the town of Cheektowaga for protecting the "no man's land" west of Transit road. The contracts had steadily increased in value through the years. By 1960 the company received \$5000.

In November of 1947 Twin District joined the Erie County Volunteer Firemen's Association. In the next year the company had its own Fire Police, and the Mutual Aid program was started. Regular drills were exercised with neighboring fire companies. In 1950 the town of Lancaster began offering training courses in first aid, but actual first aid service commenced in 1970 with Ray David and Ray Ewert as Twin District's first Emergency Medical Technicians.

The technical changes in firefighting have been many over the last fifty years. For example, the first siren system employed consisted of one siren mounted on the roof of Norm

country!) A fence was erected around the water hole; they worried about lawsuits even in the 40's.

There were a few bumps along the relatively even timeline: vandals drained the water from the truck; the town refused to plow the driveway in the winter months, (they didn't have to), and this was to be a source of contention for years; and their first major fire was a disaster. The fire report of May 6, 1946 read: "Fire at Depew Airport. Police notified. No water at scene. Traffic situation terrible and no police patrol to control it." The firemen had to push cars off the road in order to get to the fire, because Transit Road was only a double lane.

In the early days, the fire company developed an important social aspect. Although the company had a rigid organizational structure, (with fines imposed for speaking out of turn, or swearing, both 25¢, and a \$5 fine for drinking at social events), the men had a good time. After one meeting, refreshments were served — spaghetti, rabbit, and beer — and "a good time was had by all." The firehall was composed of active members and social members, and the latter group played an important role in the development of the company, as they raised much needed capital. In the 40's (and later) active and social members alike raised funds for a new building, a new truck, and a siren system. Various fundraisers were held, such as a radio raffle, a Christmas toy sale, gambling (the police didn't interrupt any games), and other events.

In March of 1948, it was suggested at one of the meetings that the company be district owned, in order to be funded for a new building, but the staunch firemen refused to relinquish their autonomy, and to this date have still retained it. Instead, they continued to hold raffles, card parties, and picnics, and one of the firemen, Mr. Alfred Kneitzbender donated one ton of coal to be raffled for the benefit of the truck fund (it was won by Mrs. O'Grady of Clark Street). A wide array of miscellany was raffled: tire chains, cases of whiskey, etc. As the minutes of a meeting of July 1948 stated, the men began "canvassing for donations for clam chowder," at times they would even raffle the chowder off, after concocting it from the donations of the community.

Marching in parades was also a major happening for the firemen of Twin District. The "Field Days" of western New York fire compan-



Petri's garage. The police would call the garage and Mr. Petri would sound the alarm. Later they added two more sirens, one on the corner of Bowen and Brunck, and another on Transit. Now all firemen have their own pagers. With today's technology and transportation, response times to calls are faster. The firemen of 1949 were pleased with their nine and one-half minute response to a call one and one-half miles away, (and they had blue lights too they were first legal that year).

The second truck purchased, in 1948, was a brand new Chevrolet truck, for \$1800 at one percent interest. Subsequent to that, a 1945 Buffalo was purchased, as well as a 1951 Ford. After that a four wheel drive Dodge grass truck was obtained for the inexhaustible rash of grass fires in the area. The district was mainly farmland, and dry grass caught fire regularly, in fact one week in the mid 40's recorded eleven. The firemen burned grass frequently in attempts to prevent fires.

Several other fires stand out in the minds of the "oldtimers". There was a fire at Mr. Ulatowski's barn on Didion Rd. in the late 1950's. The old timers claimed that they "had the cows back by six o'clock, cleaned them up a bit and put them back in the barn so he could milk them." The firemen of 1952 also saved the historical Huff's house on the corner of William and Bowen. Later that decade, at a fire at the Lancaster Country Club, which destroyed the building, a refrigerator was left standing, the firemen opened the door and out came a fully cooked roast beef.

The equipment of today consists of a 1967 Ford 1000 gallon per minute pumper, as well as a 1977 Ford purchased brand new for \$49,516. In 1979 a Chevrolet Suburban was purchased to replace the "Banana truck", a 1963 Chevrolet step van. These trucks were used as Emergency vehicles. The company also has a 1985 Pierce engine and a Pierce mini-pumper, both purchased through the Churchville Fire Equipment Company. The Pierce engine cost \$115,880 and a loan was acquired for \$96,000. The vehicles now in service replaced a 1946 Buffalo, a 1964 American LaFrance, purchased brand new, and a 1967 Young, also purchased new. These trucks lasted twenty years before being replaced.

In September of 1947, the members began working on plans for a new building. They estimated the costs to be \$10,000. In 1950 the loan was rejected, so the members were forced to decide to build themselves or obtain funds by some other means. The company opted to build the structure themselves. They spent \$1,200 to buy material, and they canvassed the district for loans and donations. The men also made an agreement to contribute either 40 hours or \$40.00 to the construction, the total cost was under \$4,000.

In 1970 the company expanded the size of the engine house to include four bays. A mortgage was obtained through M&T Trust Co. for the sum of \$45,000 to cover construction costs, and the loan was paid off by 1976. The first fifty foot addition to the hall was built in 1957 and 1958 by the members, and the Bingo hall addition was built in 1979. A local company was contracted at the cost of \$121,750. In 1982, a recreation room was built by the members.

In 1974, Twin District voted to purchase the lot next to the hall on the west side. A committe headed by fireman John Raichel obtained the land from the estate of Ameen Zaidan for the price of \$8500. The land's history is a varied one. It changed hands fifty-one times since the early 1800's Owned first by Wilhem Willink, it was transferred to the Seneca Indian Nation as part of a peace treaty in 1826. It also belonged to the Roman Catholic Church of St. Louis in 1941; finally Twin District owned it in 1974. A one and one-half story home stood on the site at the time of purchase, but the fire company burned it as part of a drill, (and found out that it was illegal to do so after the fact.)

Other accomplishments were made in the 1970's. In '76 and '77 the playground recreation area was built. Consequently, there was a dispute with the town of Lancaster because the fire company refused to sign a contract allowing the use of the company's property for town recreation purposes. In June of 1979, the #3 Engine (1945 Buffalo) was sold to Mr. Schigtel for \$1,027.89. Bingo started as a full time fundraising activity in 1973. In fact, it has become the top fundraising activity of the company. Previously, the members held country western dances, Fifties dances, Halloween parties, Christmas parties, and they rented the hall out for private affairs. These events paid for the construction done to the hall in the late 1970's. Now Bingo is the only money generating activity, and in 1991 the company purchased a new Bingo machine.

The winter of 1976 foreshadowed the coming blizzard of the next year. The company pumped out basements in the district for five days after an ice storm. During the famous Blizzard of 1977, the firemen were extremely busy. They were on call twenty-four hours a day for five days. Several members slept at the hall to assist the fifteen to twenty stranded motorists who stayed at the hall for a few days. The firemen also delivered food and medical supplies to area residents via snowmobile and four wheel drive truck. The recreation room had also been used as a snowmobile repair station for a few days. Several members made an extraordinary effort in the rescue of a brother fireman. Joe Dunnigan went into cardiac arrest during the blizzard, and he was transported by snowmobile and pulled on a toboggan to Blossom Fire hall, where he was then taken to the hospital.

The youths were advised by Jim Chiro and Jim Rozler, and the program was developed to continue the tradition of being a firefighter, and instill a sense of civic responsibility with the youths.

Teens Join Lancaster Fire Team

Inspired partly by a desire to carry on family tradition and partly by a desire to help Lancaster firefighters fight fires, seven teen-agers are becoming Twin District junior firefighters.

"So far we have seven who have signed up — four girls and three boys — but we are hoping to attract some more," explained Twin District Chief Raymond David. So far the squad includes Steven and his brother Roland Rozler, William Chiro, Lynn Bulera, Laurie Mikula, Patricia Scroger and Darlene Pruski. The junior firefighters are 15, 16 and 17 and have been issued helmets, coats and boots.

"They won't actually go into buildings to fight fires, although they could help us put out a grass fire," David said. "But they will be tending hoses and helping us clean up after the big fires. They will also work to maintain the equipment.

First Ald Lessons

The junior firefighters will also learn first aid and cardiopulmonary resuscitation.

The chief will be in charge of training the junior firefighters — who are joining their fathers in the fire company.

"They will ride to fires on the rescue trucks but we will teach them how to work the pumpers and take care of the hoses," the chief said.

The junior team will hold meetings and elect officers. They will follow certain rules such as leaving the fire hall at 4999 William St. by 10:30 p.m. or one hour after the band starts at special banquets.

"Basically the kids will be running their own shot, although we will offering the training and a little guidance," David said.

Son Joining

Buffalo Police Officer James Chiro is a member of the fire company. His son, William, 15, is joining his father at the fire hall.

"The kids seem to be excited about the whole thing and we hope that they will stay with us after they reach 18 and are able to become full-time firefighters," Chiro said.

The kids will also learn firsthand the tragic effects of fires and the company officers are hopeful that they will spread the word and help prevent fires from happening in the first place, Chiro added.

JUNIOR FIREFIGHTERS — Although 5-year-old Brian Bulera is still too young for Lancaster's Twin District junior fire fighter program, he insisted on checking out the coat and hat. The other young people have now officially joined the company and will receive training under the watchful eye of Chief Raymond David. Once again misfortune befell the company when in 1980, the Emergency 7-1 truck was stolen twice in six weeks, and the hall was broken into. It appears that records were stolen, or misplaced from the attic when renovation occurred. Consequently, there are large gaps in this document.

This fiftieth anniversary history was first thought up when Tom Bulera and Stan Nowakowski attended Millgrove's anniversary celebration in 1981. They suggested that Twin District begin planning their 50th anniversary activities. Eleven years later (!), the company planned festivities and this book, and overall Twin District is still going strong. The company now holds an Easter Egg Hunt each spring, a Halloween party, and a Santa visit (via fire truck) to the children of the community. Twin District continues to sponsor Boy Scouts and Brownies, and each year they hold an open house. After making their last payments on the new truck and the hall, the members held a mortgage burning party in 1990, and since then have been debt-free.







Community Involvement









1991 was marked by another great accomplishment in the history of the company. The firemen fought for a Service Awards program that was being implemented in many companies across the state. Through the determination and hard work of a committee headed by Paul Pijanowski, the Service Awards were obtained providing retirement benefits for volunteer firemen. The small monthly amount is based on years of service and compliance with a point system. The Service Awards program commenced when the state legislature passed the proposal in September of 1988. Two years later the firemen of Twin District formed a committee to study the possibilities of receiving these benefits. To attain greater leverage in negotiating with the town of Lancaster, John Raichel and Paul Pijanowski merged with George Mac-Peek and Carl Meyers of Bowmansville, and Norm Weber and John Weisbeck of Townline. The committee worked with the town board and selected an insurance carrier. On December 30, 1991 a referendum was held and the voters passed the program. As of January of this year, 1992, the town has budgeted money and the program is operational.

Twin District has provided a necessary and valuable community service for fifty years, growing from a one stall barn to a large building; from one home-made truck to several state-of-the-art trucks. Throughout the years membership has remained constant, and it is due to the effort of the members that the company has progressed and will continue to in the future.

Over the last 2 years, Twin District has experienced significant population growth and a subsequent increase in alarm rates. Projections are that this exceptional growth will continue. Ladies Auxiliary

The first meeting of the Ladies Auxiliary was held October 4, 1956, and the officers were Gerry Rodgers, Joe Ziemba, Frieda Gajewski, and Dorothy Konieczny. The women got together to help the firemen raise money, and as a social group. An initiation fee was assessed at three dollars in the 1960's but was soon reduced to one dollar. Like the firemen, the ladies held card parties, dances, bake sales, turkey raffles, beer parties, and Tupperware parties. They even held a wig party, which made a profit of \$91 in 1970. The ladies assisted the firemen, especially with Bingo, in running the kitchen, and providing refreshments. In 1974 the ladies bought a stove for the kitchen. But by 1979 membership had thinned to seven, and the operation of the kitchen was turned over to the firemen. The ladies also came to the aid of the community during the Blizzard of 1977, by distributing bags of groceries to the neighbors of the area. In 1982 the Auxiliary was dissolved.

The ladies regrouped in 1987, with the same goal to aid the firemen. Although the membership is still at seven, the Ladies Auxiliary continues to assist the company.
